It is an equally important part of the government's relaunch of its Policy for Global Development and its efforts to contribute to the new global sustainable development goals. The Action Plan has been developed by the government in consultation with various stakeholders.  The supply chains topic is discussed in the sections on the state duty to protect human rights and measures already taken in the field of business and human rights.
